PLAINTIFFS' AND DEFENDANTS' JOINT STATUS REPORT	

Pursuant to the Court's order on June 6, 2024 (Dkt. #94), Plaintiffs' and Defendants' counsel have conferred and file this Joint Status Report addressing the following matters:

a. Whether the Schedule A complaint can be converted to a tolling agreement.

The parties are currently discussing whether the plaintiffs listed in Plaintiffs' Schedule A and Supplement to Schedule A (Dkts. #100-1, 101-1) can be tolled pursuant to an agreed tolling agreement. The parties have met and conferred, discussed the terms of such a tolling agreement, and believe it is likely an agreement can be reached. Both parties respectfully request more time to discuss this issue and are optimistic they can come to an agreement. The parties agree to file a status report detailing the progress of these discussions and the status of an agreement by August 1, 2024.

b. A tolling agreement for non-diverse potential plaintiffs in state court.

Defendants and Plaintiffs successfully reached a tolling agreement for non-diverse potential plaintiffs in state court which imposed a deadline of June 17, 2024 for the PLC to identify non-diverse potential plaintiffs that would be subject to this agreement. Under the terms of this tolling agreement, Plaintiffs' counsel provided spreadsheets containing the names of non-diverse potential plaintiffs, as well as additional information similar to that provided in Plaintiffs' Schedule A, as an "Exhibit A" to the tolling agreements, and all statutes of limitation or repose periods related to these non-diverse potential plaintiffs' claims have been tolled up to and including June 16, 2025.
