\*\* Each side is permitted one motion of a maximum of 25-pages per representative case, which shall raise any *Daubert* and summary judgment issues in the same motion.

The Court will hold a further case management conference on November 8, 2024 at 1:30 p.m. via Zoom. The parties shall meet and confer and propose an agenda for the further case management conference, which they shall file no later than October 31, 2024.
