DEFENDANT'S MOTION FOR JUDGMENT ON THE PLEADINGS

Pursuant to Federal Rule of Civil Procedure 12(c), and for the reasons set forth in the concurrently filed Memorandum in Support, and upon all prior pleadings and proceedings in this action, Defendant Abiomed, Inc. ("Abiomed"), by and through its undersigned counsel, respectfully moves this Court for an Order dismissing Plaintiffs' claims with prejudice, together with such other relief as this Court deems equitable, just, and proper, for failure to state a claim for which relief can be granted. Abiomed submits that such relief is appropriate as the device at issue, which was utilized during a procedure performed on Decedent Nancy June Urquhart¹, was subject to premarket approval ("PMA") by way of a PMA supplement by the U.S. Food and Drug Administration ("FDA"), and therefore, Plaintiffs' claims are preempted by federal law. *See* 21 U.S.C. §§ 360k(a), 337(a).
